SUBJECT : DIVISION ORIENTATION ON THE POLICY OF COMPREHENSIVE TOBACCO CONTROL PROGRAM

DATE December 6, 2019

1. With reference to DepEd Order No 48, s. 2016 re: Policy and Guidelines on Comprehensive Tobacco Control, Surigao City Division will hold a one-day orientation training to all the District Federated Parents Teachers Association (PTA) Presidents for the effective implementation of a cohesive and comprehensive tobacco control program to promote environment in and around schools and DepEd Offices on December 19, 2019
2. This activity aims to:
 - a. educate and inform all parents and related stakeholders on the hazards of tobacco use and exposure to second-hand smoke;
 - b. make effective cessation intervention services available and accessible to all learners, teachers, non -teaching personnel and parents.
 - c. facilitate enforcement of tobacco control policies in schools and offices such as absolute smoking bans, access restrictions , ban on sponsorships, including so-called Corporate Social Responsibility (CSR) of the tobacco industry , outdoor advertising ban, the ban on promotional items for minors, and sampling restrictions as well as protection against tobacco industry interference; and
 - d. ensure strict implementation of policies on the protection against tobacco interference in the Department . .
3. Participants to this training are the Federated PTA Presidents of the 10 districts of the Division together with 2 Division Nurses 2 school heads and 2 Division Supervisors. Enclosed is the List of identified participants to this training activity.
4. Participants are expected to bring laptop and to be at the venue at 7:30AM for the registration. Please see enclosure 2 for the training matrix.

5. In order to prepare the needed resources for the sessions, a pre-work conference is scheduled on December 13 , 2019, 1:30 PM at the CID office. The following persons are expected to attend to wit;

- a. All facilitators ;
- b. Division HRTD and QATAME representatives;
- c. Education Program Supervisors for NDEP and PTA and
- d. CID Chief

6. Meals and snacks, tarpaulin, supplies, and other incidental expenses shall be charged to Division downloaded support Fund for Tobacco Control Program.
