GOVERNMENT PERMIT TO OPERATE/ GOVERNMENT RECOGNITION/ ESTABLISHMENT OF PRIVATE SCHOOLS

Please find attached Regional Order No. 001, s. 2020 dated January 2, 2020 entitled Additional Guidelines in the Processing of Government Permit to Operate (GPTO)/ Government Recognition (GR) and Establishment of New Private Schools.

A transaction slip shall be first secured from the School Management Monitoring and Evaluation (SMME) Section of the SGOD before proceeding with the payment at the Cashier Office. - 1. The field is hereby informed of the additional guidelines in the processing of Government Permit to Operate (GPTO)/Government Recognition (GR) and establishment of private school.
- 2. The following shall be the payment for the application GPTO/ GR/Establishment of school.

Permit	Application & Inspection Fee	Research Fund	School Bond	Total
1. Establishment	P 2,000,00	P 20.00	₱1,000.00	P3,020.00
2. Renewal GPTO/GR	₱ 2,000.00	P 20.00		P2,020.00

The payment shall be received and collected by the School Division Office (SDO). The official receipt shall be part of the documents in submitting at the regional office.

- 3. The official receipt shall be included in the scanned documentary requirements which shall be emailed to <u>caragaprivateschools@gmail.com</u>
- 4. Once the GPTO/GR/establishment is approved and issued, it shall be sent directly to the school through a mail courier. The school administrators are advised not to claim their permits at the Regional Office, instead wait the delivery of their permits. However, they may contact/follow-up thru email the SDO on the status of their permits.
- 5. This office shall inform the field once the GPTO/GR/establishment is approved / issued through Regional Memorandum.
