KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made and entered into this **August 21, 2020** between

WHEREAS, the entity is desirous that the Contractor execute **Contract No. FY-2020-GOODS-019** for the project **QUALITY REPRODUCTION AND DELIVERY OF MATERIALS FOR ALTERNATIVE LEARNING SYSTEM (ALS) LEARNERS OF DEPED SDO SURIGAO CITY** (hereinafter called the “Services”) and the Entity has accepted a Contract for **SIX HUNDRED SIXTY THOUSAND PESOS (PHP 660,000.00)** by the Supplier for the execution and completion of such Services and the remedying of any defects therein.

 - c. Addenda and/or Supplemental/Bid Bulletins, if any;
 - d. Eligibility requirements, documents and/or statements;
 - e. Notice of Award of Contract and the Bidder’s conforme thereto;
 - f. Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete the Services and remedy any defects in conformity with the provisions of this Contract in all respects.


