CONTRACT OF SERVICE

KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made and entered into this November 18, 2020 between

DEPARTMENT OF EDUCATION SCHOOLS DIVISION OFFICE OF SURIGAO CITY

Surigao City, Philippines (hereinafter called "The Entity")

and

ATOYAY GENERAL MERCHANDISE

Atoyay Sering, Socorro, Surigao del Norte (hereinafter called "The Supplier/Bidder").

WHEREAS, the entity is desirous that the Contractor execute Contract No. FY-2020-GOODS-030 for the project SUPPLY AND DELIVERY OF HARDWOOD BENCHES FOR DEPED SDO-SURIGAO CITY (hereinafter called the "Services") and the Entity has accepted a Contract for FIFTY-THREE THOUSAND EIGHT HUNDRED EIGHTY-SIX PESOS (PHP 53,886.00) by the Supplier for the execution and completion of such Services and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form and be read and construed as part of this Agreement, to wit:
 - a. General and Special Conditions of Contract;
 - b. Request for Quotation;
 - c. Addenda and/or Supplemental/Bid Bulletins, if any;
 - d. Eligibility requirements, documents and/or statements;
 - e. Notice of Award of Contract and the Bidder's conforme thereto;
 - f. Other contract documents that may be required by existing laws and/or the Entity.
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete the Services and remedy any defects in conformity with the provisions of this Contract in all respects.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the execution and completion of the Services and the remedying of defects wherein,

the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
