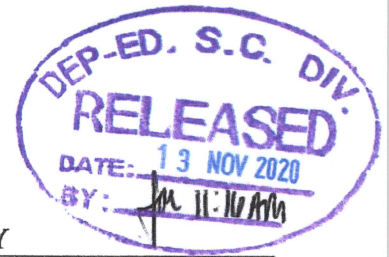

**ADDENDUM/CORRIGENDUM TO MEMORANDUM No. 178, s. 2020 RE  
THE DEVELOPMENT AND QUALITY ASSURANCE OF LEARNING ACTIVITY SHEETS  
(LAS) for the 2<sup>nd</sup> QUARTER IN ALL SUBJECT AREAS IN ALL GRADE LEVELS**

1. To give premium to the effort of the development and quality assurance team in the crafting of the division-initiated Learning Activity Sheets (LASs) which bear the features of Self-Learning Module (SLMs), this office, converts the name Learning Activity Sheets (LASs) into Self-Learning Module (SLM).
2. Attached herewith is the cover page template (enclosure 1), sample cover (enclosure 2) and the back cover template of the SLM (enclosure 3) which are the pages with changes compared to the LAS template. Inside elements or parts will remain the same. Pertaining the introduction part, the phrase previously used which is "Learning Activity Sheets (LAS) were" must be changed into "Self - Learning Module (SLM) was".

In consideration of the unstable or intermittent internet connectivity issues and the multiple tasks of the development and quality assurance teams, the evaluation phase scheduled from November 2 - 6, 2020 is extended up to November 20, 2020. On the other hand, proofreading and editing scheduled on November 9 - 13, 2020 shall be moved to November 23 - 25, 2020.
5. Uploading of the printable modules shall be done on or before November 26 and 27 to have ample time for reproduction.
6. All other items previously disseminated still stay in effect.

On the other hand, non-teaching personnel involved shall be entitled to three (3) days - Compensatory Time-Off (CTO) per Civil Service Commission (CSC), and Department of Budget and Management (DBM) Joint Circular No. 2, s. 2004 on Non-Monetary Remuneration of Overtime Service Rendered.

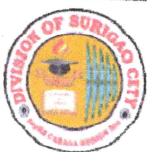

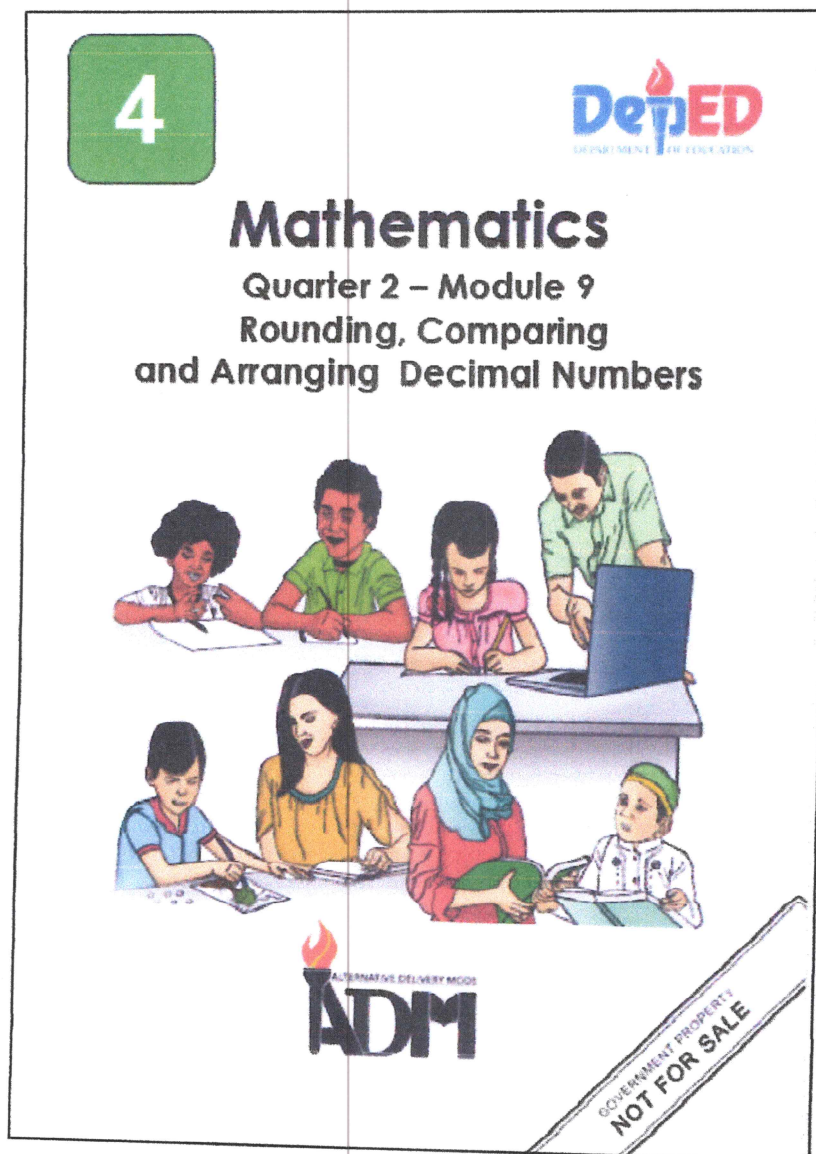
