**2021 STATUS OF SCHOOL LIBRARY
AND SCHOOL LIBRARY NEEDS SURVEY**

1. As mandated by **Republic Act No. 9246** also known as the **Philippine Librarianship Act of 2004** reinforced by the provisions under **Department of Education Order Number 56** dated **July 19, 2011** also known as **Standards for Philippine Libraries**. Reiterating the provisions under **Division Memorandum Number 351 series of 2015** also known as **Status of School Library and Inventory of Learning Resources**.
2. This Schools Division Office hereby inform and require from the Schools of the following: (a) the existence and/or status of a library in a school campus, if any, and; (b) if there is a need to establish the same.
3. The gathering of information shall be conducted by digital platform via internet access. Primarily requiring the respondent school, through its authorized representative to log-in the online survey by using the DepEd Employee's issued OFFICIAL DEPED EMAIL.
4. There shall be two online surveys to be accomplished, namely: (a) 2021 SCHOOL LIBRARY PROFILE SURVEY (SLPS) TOOL; and (b) 2021 SCHOOL LIBRARY NEEDS SURVEY (SLNS) TOOL. The Survey Tools are accessible online in the Uniform Resource Locators (URLs) and Quick Response (QR) Codes are provided as follows:
