

Note that, this is a restricted link and only official DepEd accounts of the teachers allowed by the Division Mental Health Focal/Division Guidance Coordinator shall be required to access the modules.
- 3. The distribution and collection of the modules shall be done by the school advisers and the summarization of the outputs shall be done by the Guidance Support Staff and Mental Health Coordinators.
- 4. Summary of outputs shall be submitted to the Division Mental Health Focal/Division Guidance Coordinator.
- 5. Refer immediately to the Division Mental Health Focal/Division Guidance Coordinator for any emotional, mental, and psychological problems found.
- 6. Consolidation of the submitted outputs shall be in care of Ana Nijin S. Namuag, Division Nurse, and Kristia Mae D. Echin.
- 7. Budget for reproduction shall be charged to the school MOOE subject to the usual auditing rules and regulations.
