
1. The Department of Education through the Bureau of Learning Resources (BLR), issued **Department of Education (Dep Ed) Memorandum No. 090 s. 2019**, mandating the implementation of the **3rd NATIONAL COMPETITION ON STORYBOOK WRITING**, supported by our Division through the stipulations provided by **Division Memorandum No. 220 s. 2019**.
2. Relevant thereto, it is stipulated under Section 5.7.1 – **Division Manuscript Screening (DMS), Enclosure No. 1 Guidelines for The 3rd National Competition on Storybook Writing of Dep Ed Memorandum No. 090 s. 2019 paragraph (j)**, hereto quoted as follows:

“...the Division Secretariat shall facilitate the creation of the DIVISION SCREENING COMMITTEE (DSC), which shall be composed of at least five (5) members and will be headed by the Schools Division Superintendent. The DSC will have at least one (1) judge teaching Kindergarten, Grade 1, Grade 2, or Grade 3 in a non – participating school...”
3. It follows therefore that this Division shall establish the Division Screening Committee (DSC) in compliance with the requirements mentioned in the instant Guidelines.

- f. **ANGELINE R. VILLASOR, PhD** – DSC Member/ Principal II / Division MTB-MLE Coordinator
 - g. **To be identified** – DSC Member teaching Kindergarten, Grade 1, 2, or 3 from a non – participating School
5. In addition, this Division shall implement the Score Sheet (refer to Enclosure no. 1, hereto attached) as the official form/template in placing scores in relation to judging and/or screening Division level of entry manuscripts pursuant to the Guidelines in the storybook writing competition, specifically the criteria (refer to Enclosure No. 5 DepEd Memorandum No. 090 s. 2019).
 6. Furthermore, this Division announces the **deadline** for the submission of entries for the Storybook Writing Competition. The deadline for submission shall be on or before **SEPTEMBER 2, 2019**.
