- This office, through the Learning Resources Management and Development System (LRMDS) Section hereby inform the field of Regional Memorandum No. 510 s. 2019, entitled REGIONAL LEVEL COMPETITION ON STORYBOOK WRITING 2019;
- 2. The **Regional Screening** of storybooks with design and illustration shall be held on **October 18 19, 2019** at the Regional Office;
- 3. Public Schools District Supervisors (PSDS) and Public Elementary and Public Secondary School Heads are enjoined to **invite and encourage** any and all Teacher-Illustrators, Teacher-Layout Designers, or Teacher-Illustrators who at the same time are also designated Layout Designers to **join** the said Regional Competition;
- 4. The PSDS and School Heads are obligated to submit the list of names of the contestants with their mobile phone number through a formal letter addressed to the Schools Division Superintendent on or before September 18, 2019;
- 5. The interested contestants are advised to comply with the following tasks:
 - a. Bring with them the accomplished Official Entry Form for Graphic Designers PERSONAL INFORMATION AND ASSIGNMENT OF RIGHTS (attached herewith), duly signed by the interested contestant and his/her immediate superior (i.e. School Head or PSDS);
 - b. Join the and Orientation and Distribution of Storybook Manuscripts to be illustrated at the LRMDC- DepEd Caraga, Butuan City on September 20, 2019 and to see Regional Education Program Supervisor Maripaz F. Magno.
- 6. Once assigned with a storybook manuscript, the contestant shall proceed with illustration and lay-out thereof, bearing in mind to be faithfully compliant with the lay-out and illustrating instructions stipulated by the author on the manuscript.
- 7. The contestant shall submit the storybook with layout, design, and illustration, both in PRINT and SOFT copy with the editable digital version of the illustration, on or before 5:00 PM, October 14, 2019, at the LRMDS Section, Schools Division Office of Surigao City, Surigao City;
