Invitation to Bid for REPAIR AND REHABILITATION OF TWO (2) CLASSROOM SCHOOL BUILDING OF SERNA ES OF DEPED SDO SURIGAO CITY

- 1. The Department of Education Division of Surigao City, through the General Appropriations Act (GAA) 2021 intends to apply the sum of ONE MILLION FIVE HUNDRED NINETY-ONE THOUSAND THREE HUNDRED EIGHTY-FOUR PESOS AND SEVENTY-SEVEN CENTAVOS (PHP 1,591,384.77) being the Approved Budget for the Contract (ABC) to payments under the contract for REPAIR AND REHABILITATION OF TWO (2) CLASSROOM SCHOOL BUILDING OF SERNA ES OF DEPED SDO SURIGAO CITY (FY-2021-INFRA-003). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of Education Division of Surigao City now invites bids for the above Procurement Project. Completion of the Works is required one hundred twenty (120) days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from *Department of Education Division of Surigao City* and inspect the Bidding Documents at the address given below from *Mondays to Fridays*, 8:00AM to 5:00PM.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *June* 5, 2021 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (PHP 5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, or through electronic mail.
- 6. The Department of Education Division of Surigao City will hold a Pre-Bid Conference on June 14, 2021, 10:00AM at the Office of the Assistant Schools Division Superintendent and/or through videoconferencing/webcasting via google meet with the link https://meet.google.com/fgz-huve-rbr, which shall be open to prospective bidders.

- 7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both on or before *June 28, 2021, 2:00PM*. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on *June 28, 2021, 2:00PM* at the given address below and/or through *google meet with the link https://meet.google.com/fgz-huve-rbr*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity provided they present a Special Power of Attorney (SPA).
- 10. A link intended for the bidder shall be provided for those who will be submitting their bidding documents online. The link will be closed on June 28, 2021, 2:00PM.
- 11. The *Department of Education Division of Surigao City* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
