BAC Resolution Declaring LCRB and Recommending Approval

WHEREAS, the Department of Education, Division of Surigao City has advertised through PhilGEPS and posted at a conspicuous place within the premises of the division office for the **REPAIR AND REHABILITATION OF TWO (2) STOREY (OSDS BUILDING) AND THREE (3) STOREY (SGOD AND CID BUILDING) DIVISION OFFICE BUILDINGS OF DEPED SDO SURIGAO CITY**, the same in the Department of Education, SDO of Surigao City continuously for seven (7) days as required in Annex “H” of 2016 Revised Implementing Rules and Regulations for Public Bidding;

WHEREAS, in response to the said advertisement, three (3) bidder/s submitted their Bidding Documents;

WHEREAS, the bidders passed the preliminary examination of the bids;

WHEREAS, the bid proposal of the bidder was found to be substantially complying as follows:

WHEREAS, the detailed evaluation of bids conducted on April 18, 2022 resulted in the following:

2. RADIAN CONSTRUCTION AND SUPPLY	PHP 2,982,466.52	11.00%
3. ATJ BUILDERS	PHP 3,350,149.27	0.03%

WHEREAS, upon careful examination, validation, and verification of all the quotation documents submitted by the bidder with the Lowest Calculated Bid, its bid was found to be responsive;


