
WHEREAS, upon careful examination, validation, and verification of all the quotation documents submitted by the bidder with the Single Calculated Bid, its bid was found to be responsive;

NOW, THEREFORE, we the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:




