WHEREAS, the Department of Education, Division of Surigao City has advertised through PhilGEPS and posted at a conspicuous place within the premises of the division office for the PROCUREMENT OF HIGH QUALITY PRINTING SUPPLIES FOR THE PROVISION OF LEARNING RESOURCES TO KINDER TO GRADE 12 LEARNERS (LOT 1), the same in the Department of Education, SDO of Surigao City continuously for seven (7) days as required in Annex “H” of 2016 Revised Implementing Rules and Regulations for Public Bidding;

WHEREAS, in response to the said advertisement, three (3) bidder/s submitted their quotations;

WHEREAS, the bidders passed the preliminary examination of the bids;

WHEREAS, the bid proposal of the bidder was found to be substantially complying as follows:

The detailed bid evaluation resulted in the following:



NOW, THEREFORE, we the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


