


NOW, THEREFORE, we the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:



- b.) To recommend for the approval of the Schools Division Superintendent of the Department of Education, Division of Surigao City the foregoing findings.


