Invitation to Bid for CONSTRUCTION OF ONE (1) STOREY - FOUR (4) CLASSROOMS SCHOOLS BUILDING (WITH COMMON TOILET) WITH PROVISION OF RAINWATER COLLECTOR, SCHOOL FURNITURE, SOLAR PV ENERGY SYSTEM, AND WATER SYSTEM

- 1. The *Department of Education, Division of Surigao City*, through the *General Appropriation Act of 2023* intends to apply the sum of *TWENTY TWO MILLION ONE HUNDRED SEVENTY ONE THOUSAND FOUR HUNDRED ONE PESOS AND EIGHTY TWO CENTAVOS (PHP 22,171,401.83)* being the Approved Budget for the Contract (ABC) to payments under the contract for *FY-2023-INFRA-015*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The *Department of Education, Division of Surigao City* now invites bids for the above Procurement Project. Completion of the Works is required 160 (160) days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from the *Department* of Education, Division of Surigao City and inspect the Bidding Documents at the address given below from 8:00 am 5:00 pm, Mondays to Fridays, excluding regular holidays.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *December 10, 2023* from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of 25,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
- 6. The Department of Education, Division of Surigao City will hold a Pre-Bid Conference on December 18, 2023, 2:00 pm at the Office of the Assistant

Schools Division Superintendent, Department of Education Division of Surigao City, M. Ortiz St., Brgy. Washington, Surigao City, Surigao del Norte and/or through videoconferencing/webcasting via the link https://meet.google.com/fgz-huve-rbr, which shall be open to prospective bidders.

- 7. Bids must be duly received by the BAC Secretariat through (i) manual submission at the office address as indicated below, (ii) online or electronic submission as indicated below, or (iii) both on or before January 5, 2024, 10:00AM. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on *January 5*, 2024 at the given address below and/or through the link https://meet.google.com/fgz-huve-rbr. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity provided a Special Power of Attorney is submitted for the representative attending.
- 10. A link will be provided upon payment of the applicable fee for the Bidding Documents, for those who will submit their Bidding Documents online.
- 11. The *Department of Education, Division of Surigao City* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
