WHEREAS, the Bids and Awards Committee and its Technical Working Group conducted a Post Qualification of the firm last September 12, 2024.




NOW. THEREFORE, we the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- b.) To recommend for the approval of the Schools Division Superintendent of the DepEd, SDO of Surigao City the foregoing findings.


