INVITATION TO BID FOR REPAIR AND REHABILITATION/ RESTORATION OF GABALDON SCHOOL BUILDING (14 CLASSROOM) OF SCPS

- 1. The *Department of Education, Division of Surigao City*, through the *General Appropriation Act of 2024* intends to apply the sum of *FIVE MILLION FOUR HUNDRED NINETEEN THOUSAND SEVEN HUNDRED THIRTY SIX PESOS AND SIXTY EIGHT CENTAVOS (PHP 5,419,736.68)* being the Approved Budget for the Contract (ABC) to payments under the contract for *FY-2024-INF-025*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Department of Education, Division of Surigao City now invites bids for the above Procurement Project. Completion of the Works is required one hundred twenty (120) days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criteria as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from the *Department* of Education, Division of Surigao City and inspect the Bidding Documents at the address given below from 8:00 am 5:00 pm, Mondays to Fridays, excluding regular holidays.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on *October 24*, 2024 from given address and website/s below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of 10,000.00. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.
- 6. The Department of Education, Division of Surigao City will hold a Pre-Bid Conference on October 31, 2024, 10:00 am at the Office of the Assistant Schools Division Superintendent, Department of Education Division of Surigao City, M. Ortiz St., Brgy. Washington, Surigao City, Surigao del Norte and/or through videoconferencing/webcasting via the link

- https://meet.google.com/fgz-huve-rbr, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before *November 13, 2024, 2:00 pm.* Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
- 9. Bid opening shall be on *November 13, 2024* at the given address below and/or through *the link https://meet.google.com/fgz-huve-rbr.* Bids will be opened in the presence of the bidders' representatives who choose to attend the activity provided a Special Power of Attorney is submitted for the representative attending.
- 10. A link will be provided upon payment of the applicable fee for the Bidding Documents, for those who will submit their Bidding Documents online.
- 11. The *Department of Education, Division of Surigao City* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
