 BAC RESOLUTION DECLARING LCRB AND RECOMMENDING APPROVAL

WHEREAS, the Department of Education, Division of Surigao City through its Bids and Awards Committee conducted a procurement for the project SUPPLY AND DELIVERY OF NUTRITIOUS FOOD PRODUCT FOR SCHOOL-BASED FEEDING PROGRAM SY 2025-2026 FOR 120 FEEDING DAYS OF DEPED, SURIGAO CITY DIVISION (LOT 2).

WHEREAS, the detailed evaluation of bids conducted by the Technical Working Group and the Bids and Awards Committee found that THE LIFE GIVING PRODUCTS AND SPECIALTY (MANHU-THE LIFE GIVING BREAD) CORP. is the Lowest Calculated Bid.

WHEREAS, the Bids and Awards Committee and its Technical Working Group conducted a Post Qualification of the firm last May 29, 2025.

WHEREAS, upon careful examination, validation, and verification of all the documents submitted and presented by the bidder with the Lowest Calculated Bid, its bid was found to be responsive;

NOW, THEREFORE, we the members of the Bids and Awards Committee, hereby as resolve follows:

- a.) To declare THE LIFE GIVING PRODUCTS AND SPECIALTY (MANHU-THE LIFE GIVING BREAD) CORP. as the Bidder with the Lowest Calculated and Responsive Bid for the SUPPLY AND DELIVERY OF NUTRITIOUS FOOD PRODUCT FOR SCHOOL-BASED FEEDING PROGRAM SY 2025-2026 FOR 120 FEEDING DAYS OF DEPED, SURIGAO CITY DIVISION (LOT 2) with a contract amount of ONE MILLION TWO HUNDRED EIGHTY FOUR THOUSAND SEVENTY FIVE PESOS (PHP 1,284,075.00).
- b.) To recommend for the approval of the Schools Division Superintendent of the DepEd, SDO of Surigao City the foregoing findings.

RESOLVED FURTHER, that this resolution shall be made part of the records of the procurement proceedings for the project.
