**BAC RESOLUTION DECLARING LCRB AND RECOMMENDING APPROVAL**

WHEREAS, the Department of Education, Division of Surigao City through its Bids and Awards Committee conducted a procurement for the project SUPPLY AND DELIVERY OF NUTRITIOUS FOOD PRODUCT FOR SCHOOL-BASED FEEDING PROGRAM SY 2025-2026 FOR 120 FEEDING DAYS OF DEPED, SURIGAO CITY DIVISION (LOT 9).


NOW, THEREFORE, we the members of the Bids and Awards Committee, hereby as resolve follows:


