BAC RESOLUTION DECLARING LCRB AND RECOMMENDING APPROVAL

WHEREAS, the Department of Education, Division of Surigao City through its Bids and Awards Committee conducted a procurement for the project THIRD POSTING: SUPPLY AND DELIVERY OF NUTRITIOUS FOOD PRODUCT FOR SCHOOL-BASED FEEDING PROGRAM SY 2025-2026 FOR 120 FEEDING DAYS OF DEPED, SURIGAO CITY DIVISION (LOT 5).

To declare JJEM FOOD PRODUCTS CORPORATION as the Bidder with the Lowest Calculated and Responsive Bid for the THIRD POSTING: SUPPLY AND DELIVERY OF NUTRITIOUS FOOD PRODUCT FOR SCHOOL-BASED FEEDING PROGRAM SY 2025-2026 FOR 120 FEEDING DAYS OF DEPED, SURIGAO CITY DIVISION (LOT 5) with a contract amount of ONE MILLION TWO HUNDRED EIGHTY SEVEN THOUSAND PESOS (PHP 1,287,000.00).
- b.) To recommend for the approval of the Schools Division Superintendent of the DepEd, SDO of Surigao City the foregoing findings.
