BAC RESOLUTION DECLARING LCRB AND RECOMMENDING APPROVAL

WHEREAS, the Department of Education, Division of Surigao City through its Bids and Awards Committee conducted a procurement for the project PRINTING AND DELIVERY OF LESSON EXEMPLARS AND LEARNING ACTIVITY SHEETS (LAS) FOR GRADES 2, 3, 5 AND 8 FOR THE IMPLEMENTATION OF THE MATATAG CURRICULUM.

To declare MAX COPY CENTER as the Bidder with the Lowest Calculated and Responsive Bid for the PRINTING AND DELIVERY OF LESSON EXEMPLARS AND LEARNING ACTIVITY SHEETS (LAS) FOR GRADES 2, 3, 5 AND 8 FOR THE IMPLEMENTATION OF THE MATATAG CURRICULUM with a contract amount of TWO MILLION ONE HUNDRED SIXTY THOUSAND PESOS (PHP 2,160,000.00).
- b.) To recommend for the approval of the Schools Division Superintendent of the DepEd, SDO of Surigao City the foregoing findings.


