BAC RESOLUTION DECLARING LCRB AND RECOMMENDING APPROVAL

WHEREAS, the Department of Education, Division of Surigao City through its Bids and Awards Committee conducted a procurement for the project THIRD POSTING: SUPPLY, DELIVERY, AND INSTALLATION OF SMART TV FOR THE PROVISION OF LEARNING RESOURCES TO KINDER TO GRADE 12 LEARNERS.

To declare DIMDI CENTRE, INC. as the Bidder with the Lowest Calculated and Responsive Bid for the THIRD POSTING: SUPPLY, DELIVERY, AND INSTALLATION OF SMART TV FOR THE PROVISION OF LEARNING RESOURCES TO KINDER TO GRADE 12 LEARNERS with a contract amount of ONE MILLION FOUR HUNDRED EIGHTY EIGHT THOUSAND PESOS (PHP 1,488,000.00).
- b.) To recommend for the approval of the Schools Division Superintendent of the DepEd, SDO of Surigao City the foregoing findings.
