BAC RESOLUTION DECLARING LCRB AND RECOMMENDING APPROVAL

WHEREAS, the Department of Education, Division of Surigao City through its Bids and Awards Committee conducted a procurement for the project REPAIR AND REHABILITATION OF 2 STY SCHOOL BUILDINGS (2CL) OF SURIGAO CITY SPECIAL SCIENCE ELEMENTARY SCHOOL.

WHEREAS, the detailed evaluation of bids conducted by the Technical Working Group and the Bids and Awards Committee found that RBEP CONSTRUCTION is the Lowest Calculated Bid.

WHEREAS, the Bids and Awards Committee and its Technical Working Group conducted a Post Qualification of the firm last September 19, 2025.

WHEREAS, upon careful examination, validation, and verification of all the documents submitted and presented by the bidder with the Lowest Calculated Bid, its bid was found to be responsive;

NOW. THEREFORE, we the members of the Bids and Awards Committee, hereby as resolve follows:

- a.) To declare RBEP CONSTRUCTION as the Bidder with the Lowest Calculated and Responsive Bid for the REPAIR AND REHABILITATION OF 2 STY SCHOOL BUILDINGS (2CL) OF SURIGAO CITY SPECIAL SCIENCE ELEMENTARY SCHOOL with a contract amount of ONE MILLION EIGHTY EIGHT THOUSAND SEVEN HUNDRED SEVENTY SEVEN PESOS AND THIRTY EIGHT CENTAVOS (PHP 1,088,777.38).
- b.) To recommend for the approval of the Schools Division Superintendent of the DepEd, SDO of Surigao City the foregoing findings.

RESOLVED FURTHER, that this resolution shall be made part of the records of the procurement proceedings for the project.


