BAC RESOLUTION DECLARING LCRB AND RECOMMENDING APPROVAL

WHEREAS, the Department of Education, Division of Surigao City through its Bids and Awards Committee conducted a procurement for the project REPAIR AND REHABILITATION OF VARIOUS SCHOOL BUILDINGS (1CL) OF TOMAS FLORYA MEMORIAL ELEMENTARY SCHOOL.

WHEREAS, the detailed evaluation of bids conducted by the Technical Working Group and the Bids and Awards Committee found that RBEP CONSTRUCTION is the Lowest Calculated Bid.

WHEREAS, the Bids and Awards Committee and its Technical Working Group conducted a Post Qualification of the firm last September 19, 2025.

WHEREAS, upon careful examination, validation, and verification of all the documents submitted and presented by the bidder with the Lowest Calculated Bid, its bid was found to be responsive;

NOW. THEREFORE, we the members of the Bids and Awards Committee, hereby as resolve follows:

- a.) To declare RBEP CONSTRUCTION as the Bidder with the Lowest Calculated and Responsive Bid for the REPAIR AND REHABILITATION OF VARIOUS SCHOOL BUILDINGS (1CL) OF TOMAS FLORYA MEMORIAL ELEMENTARY SCHOOL with a contract amount of EIGHT HUNDRED NINETY FOUR THOUSAND NINE HUNDRED NINETY EIGHT PESOS AND NINETY SEVEN CENTAVOS (PHP 894,998.97).
- b.) To recommend for the approval of the Schools Division Superintendent of the DepEd. SDO of Surigao City the foregoing findings.
